All pilots must be validated by their NAC and registered in the online FAI Sporting License Database <https://fai.org/sporting-licences> and <https://sportinglicences2.fai.org/login> prior to the start of the Championship.

NACs must nominate the pilots they wish to enter in the Championship in the order of their desired selection (National team first) on the form below by **January 19th, 2020**, with the pilot's CIVL ID number. An authorized NAC representative must sign this form, with official stamp if applicable. (Use the free Adobe Reader DC to do this on-line, <https://acrobat.adobe.com/us/en/acrobat/pdf-reader.html>)
