- These classes are defined in the FPVL Competition Rules for the National Championship, Version RC2019 - V1.0 (Section 4.3.1)

- In each of the individual classes, prizes will only be awarded if a minimum of 3 pilots are scored in the competition.

- Uncertified wings will not be allowed to participate

- Certified wings are those approved according to the standards EN926-1 and EN926-2 to the classifications A, B, C or D, as well as the old standard DHV / LTF with the ratings 1, 1-2, 2, 2-3 and 3. CIVL Competition Class (CCC) certified gliders are also allowed.

SELECTION AND REQUIREMENTS

Maximum number of pilots: 100

Eligibility

The eligibility to participate on this competition is ruled by the provisions of paragraphs 2.7 and 2.9 of the FPVL Competition Rules. Basically the requirements are:

- The Portuguese pilots are required to have FPVL license level 2 valid for the current year.
- The international pilots must have a valid FAI sporting license or present a valid national licence and present an IPPI card level 4 or superior.
 - When registering to the event, the pilot are explicitly:
 - 1. Giving his permission for use of his personal data for all purposes related to the competition, as well as in any actions to promote sport.
 - 2. Assigns all image rights to the organization for use in promotional activities related to the event, the sports and the federative activity

Selection criteria for national pilots:

In online registration order – No In WPRS order – Yes 50 Places reserved for Portuguese pilots based on National Ranking on 31-12-2020

Selection criteria for non-national pilots:

In online registration order – No In WPRS order – Yes 40 places are reserved for non-national pilots according to the WPRS on 31-12-2020

Insurance

The insurance must cover incidents on paragliding competitions and have the following minimum coverage:

- Death: 28.500 EUR
- Permanent disability: 28.500 EUR
- Medical Treatment and Repatriation: 5.000 EUR
- Funeral expenses: 2.280 EUR
- Third-party liability of 150.500 €

On registration, an insurance with the above coverage, can be subscribed by the amount of 120€

ENTRY FEE AND SERVICES PROVIDED

Entry Fee: 240 Euros

This value includes the optional retrieval and overall transportation provided by organization. Pilots opting-out to this service will pay a reduced fee of $135 \in$.

Refund Policy:

Pilot cancellation

• If a pilot, cancel after payment and up to 15 days before the start of the competition, the registration fee will be refunded less $60 \in$ hold for administrative costs.

• In case of cancellation during the 15 days prior to the start of the competition, the refund will be 50% of the registration fee.

Cancellation by the organization for reasons beyond its control:

• In case of cancellation of the event within 10 days of the start of the event, the registration fee will be refunded with less € 30, which will be used to cover part of the costs with the organization.

• In case of cancellation of the race in a period exceeding 10 days of the start of the race, return shall be the registration fee less 10 € which will be used to cover part of the costs to the organization.

Cancellation should be asked by email to eventos@landfor.pt. The cancellation date shall be taken as the date of receipt of the email. The entry fee payment is not transferable to another pilot in the event of cancellation.

LIVE TRACKING

SCORING

GPS Flight Verification.

The downloaded tracks from live-tracking system will be the primary source of GPS flight verification and scoring. Only in case or errors or doubt will be necessary to download an alternative track from pilots own GPS. Only devices approved by CIVL can be used and is the pilot's responsibility to supply the GPS cable for connecting his GPS to the organization computer.

Scoring formula:

The scoring program will be FsComp FS 2020 R1.10

The scoring system to be used is GAP2018, with "leading points", using the Leading weight factor parameter = 1 and the following FS and GAP parameters:

- FTV Factor: 20 %
- Minimum Distance: 5 km
- Nominal Distance: 30 km
- Nominal Time: 1.0 h
- Nominal Launch: 96% of pilots
- Nominal Goal: 10 % of pilots
- Score-back time: 5 min





COMPLAINTS AND PROTESTS

As per Section 7 and 7A.

After the provisional results are published, the pilot may file a complaint by the end of the day, or within 1 hour if it is the last task of the competition. Before the formal presentation of any complaint, it must be transmitted, informally, by the pilot to the pilots committee, which will take charge of trying to resolve it with the competition director.

Complaints must be made in writing, addressed to the director of competition, who is responsible for deliberating on them, and their reasoned decision must be issued in writing as soon as possible.

If the complainant is not satisfied with the result, he / she has one hour after the announcement of the decision to file a protest. Protests must be made in writing, addressed to the Jury of competition, accompanied by a deposit of 25 Euros, which will only be returned to the pilot in the event that the competition Jury decides in his favor.

The definitive official Results can only be promulgated after the period for the submission of complaints and protests has passed and, if these exist, after they have been decided.

Pilots who present protests that are considered abusive by the Jury of Competition are subject to penalties of up to 50% of points that they reached in their respective sleeve

RETRIEVING SYSTEM

- The retrieving system is based on live trackers and application "Telegram". The safety landing report procedure is also based on "Telegram", so every pilot is required to install that application on their mobile phone. The instructions how to operate the system will be provided on the opening briefing. (link)

- The organization use the following frequencies:

143,925 MHz – flight/emergency

143.950 MHz – retrieval

A use of a radio capable to operate on these frequencies is mandatory. Only these frequencies are allowed.

DAILY PILOT PROCUDERES

a) The Live Tracking devices provided by the organization, must be picked-up daily at headquarters, and handed back daily at GPS Download.

b) Picking-up the Live Tracking device before each task represents the pilot's intention to take-off and is mandatory. The devices should be maintained turned ON until they are returned to the secretariat at the end of each day;

Pilots that don't pick-up his tracker is considered out for the day.

c) In the event the pilot does not take-off within the launch window, the pilot is required to inform the launch officer using the retrieve system based on Telegram app, and hand back the live tracking device at the headquarters.

d) The pilot is required to make a safe landing report. The absence of this report implies the activation of safety procedures like search and rescue. For this reason, the violation of this rule is considered a serious fault, penalized according to FPVL Competitions Rules.e) The coordinates system to be used and the contact phone number will be announced in

the general race briefing.

f) In case of difficulties in communication by Telegram or phone, we recommend the use of radios and vice versa.

g) While awaiting retrieval, pilots should keep the radio connected on retrieval frequency, to allow communication with retrieval vehicle.

h) In the case of a cancelled task, every pilot must return to the headquarters and make his checkout, returning the tracker. It is forbidden to take-off before the return of the tracker.

PENALTIES

In addition to the penalties defined in section 3.19 of FPVL Competitions Rules, the following will be used:

• The violation of the rule d), implies the application of a penalty equivalent to "Failing the return of GPS" on point 3.20.3 of Competition rules.

• Aerobatics: For the purposes of the penalty "aerobatics above the goal area", aerobatic maneuvers are considered to be the maneuvers mentioned on the FAI rules for aerobatic competitions.

Among others, we call your attention to the following situations that might be penalized:

• Not listening to the flight/emergency frequency during flights.

• Not accepting instructions from competition director, namely in the event of task cancellation or stopping.

• Incorrect GPS track log: the Starting Point is incorrect/missing; Track Log is nonexistent.

· Disrespecting the rules of the air

TRANSLATION of relevant FPVL Competitions Regulations Section 3.20 Penalties

Penalties inflicted to a pilot by the organization (Competition Director) or by the Jury may vary from a minimum of 1 point up to the pilot's disqualification or the exclusion from the competition. Official Warnings might also be used.

The following situations will be penalized as hereby stated:

Cloud Flying (point 3.7):

- 1st offence zero points for the task
- 2st offence expelled from the competition
- This penalty might not be applied in the event of the pilot undoubtedly demonstrating that no advantage was gained by cloud flying, by putting himself (after leaving the cloud) in the altitude and distance to the next turn point that he had before entering the cloud.

Non authorized airspace violation (horizontal or vertical):

- Up to 50 meters penalty points calculated based in the following formula: N3/250 (rounded by excess to the closest integer), where N is the number of meters of infringement. Annex B includes a table with the calculation of this penalty for the first 50 meters.
- Infringement in excess of 50 meters zero points for the task
- Intentional violations should be penalized with "expelled from the competition" (altitude control will be performed solely by GPS altitude)

Failing to send the Safe Landing Report (point 3.10.3):

- 1st offence zero points for the task
- 2st offence expelled from the Competition

Wrong turning direction (up to the start, or in a 1km radius from take-off in the event of a ground start):

- 1st offence warning
- 2st offence 100 points, doubled for every subsequent offence.

Dangerous or aggressive flying:

- 1st offence warning
- 2st offence 100 points, doubled for every subsequent offence

Aerobatics in the goal area:

- 1st offence warning
- 2st offence 100 points, doubled for every subsequent offence
- Landing at the take-off area ("Top Landing") after window opening:
 - 1st offence
 - 100 points, doubled for every subsequent offence

Ballast in excess (point 3.6):

- 1st offence 100 points
- 2st offence zero points for the task
- 3rd offence expelled from the competition

Failing to deliver GPS for track log download: (pilots that take-off)

• 1st offence – expelled from the competition with zero points for all the tasks Fraud attempt regarding glider certification level (point 3.20.9):

- 1st offence expelled from the competition with zero points for all the tasks
 - Depending on the take-off/non-take-off control system to be used by the organization the following penalties can be used.

Failing to sign the take-off control sheet:

- 1st offence 20% of the pilot's task points;
- 2nd offence zero points for the task

Failing to inform of non-take-off (pilot's decision or due to conditions changing at takeoff):

- 1st offence 20% of the pilot's next task points;
- 2nd offence 50% of the pilot's next task points;

(...)

Penalties for offences occurring on days when the task is cancelled or not validated, will be applied to the scores obtained in the first subsequent valid task. In the event a subsequent valid task does not occur, the penalties will be applied to the scores obtained in the previous task

All penalties and warnings will be recorded in the official results sheets

COVID19

At the start of the competition, all the recommended sanitary measures advise by Portuguese Sanitary Authorities (Direção-Geral Saude - DGS) will be implemented.

These measures can in some way influence the normal functioning of the event, and will be clearly communicated before the start of the competition and will be mandatory for all pilots.

We must obey to national rules in place and respect the limits imposed. Currently, in Portugal, the use of masks is mandatory in all situations, including on the street and open-air locations. Pilots are required to provide for themselves:

Surgical type masks and wear these in all competition transport, gatherings, briefings etc.
 Hand sanitiser is required before entering competition vehicles.

ANY pilot failing in their duties as directed by the Portuguese authorities and/or competition organisation will be expelled from the competition without additional warning.
