**COMPLAINTS AND PROTESTS**

- Complaints and Protests will be dealt with according to the procedures in Section 7C and General Section. A complaint may be made to the Meet Director or deputy, preferably by the Team Leader. It should be made with the minimum delay and it will be dealt with expeditiously.
- If the complainant is not satisfied with the outcome, the Team Leader may make a protest in writing to the Director. The time limit for protests is 1 hours after notification of the result of the complaint. The protest fee is 37EUR (50,000KRW). It will be returned if the protest is upheld.
