Selection

Requirements for participants in the competition and conditions for their admission

1. The strongest athletes of the constituent entities of the Russian Federation participate in sports competitions.
2. Sportsmen of sports teams of the constituent entities of the Russian Federation are allowed to participate in sports competitions. Only one sports team can be entered from one subject of the Russian Federation.

(Initially, a preliminary application, certified by the regional federation, is required, the final admission according to the application signed by the regional authorities to the subject of the federation one month before the start of the competition, or at the time agreed with the organizers).

Further according to the provisions;

Quote:

Athletes who meet the qualification admission criteria outside the combined teams of the constituent entities of the Russian Federation are allowed to participate if the total number of athletes of the sports combined teams of the constituent entities of the Russian Federation is less than the maximum possible number of participants. In this case, the selection of athletes for participation among the declared athletes who meet the criteria for admission by qualification can be carried out according to the rules specified in the competition regulations.

Additional requirements for athletes outside the national teams of the constituent entities of the Russian Federation, in order of priority;

- a) Top 100 rating of the Russian Federation,
- b) experience of cross-country flights in mountain conditions, a break of no more than one year
- c) participation in competitions in Kurai in previous years.
