### **DOCUMENTS REQUIRED AT REGISTRATION:**

- .- Valid FAI license
- .- Insurance . Pilots must have an insurance with coverage for paragliding in Colombia , the pilots must verify the validity of their insurance for flying in competitions in Colombia.
- .- Third party insurance
- .- Signed release of liability , Waiver of legal rights

### **CANCELLATION AND REFUND POLICY REFUNDS:**

Any pilot who cancels their registration will be given a refund as follows (based on Full Entry Fee): • Cancellation date more than 60 days before competition start date: 75% refund • Cancellation date between 60 and 30 days before competition start date: 40% refund • Cancellation date less than 30 days before competition start date: 0% refund Any pilot proving (with medical certificate) incapacity to compete through illness should contact the organiser as soon as possible. Any refund, if appropriate, will be decided by the Organisation. Refunds will NOT be issued to ill/injured pilots cancelling within 7 days of the start of a competition regardless of personal circumstances..

### **TRACKERS :**

Pilots will be assigned trackers at beginning of the meet which will be marked with pilots name and pilot number . If pilot does not claim tracker before task and flies with out it , will receive zero points for the day .

Pilots must hand back their trackers at the end of each task to meet organizers personally .

If pilot loses tracker , the meet organizer will charge Euro 250 to pilot which must be paid same day or pilot will not receive a replacement tracker for next tasks.

### **TAKEOFF :**

.- A pilot who enters the take-off zone is obliged to take off, unless the Take-off Judge allows it due to bad conditions. If you do not take off after 2 minutes or 3 attempts, you must leave the take-off area.

.- A pilot who ignores the orders of the Takeoff Judge or behaves in an unsportsmanlike manner, may be penalized with all the points of the heat.

.-Task Committee and top ten pilots in FAI ranking (day one) and top ten in accumulated score will have priority to launch.

.- Re-take off will not be allowed, except in an emergency, landing in the vicinity of take- off, as long as it is carried out within the window hours, and after prior communication to the Competition Director

### **AIRSPACE:**

Penalty for vertical or horizontal airspace – 1 pct of pilots score for that day per meter of infringed airspace

### **COMPLAINTS AND PROTESTS :**

Complaints will be dealt with as per the FAI SPorting Code, Section 7 and its sub-

## **TRANSPORTATION :**

### **Pilot Transportation and Check-In Protocol**

It is the pilot's responsibility to be on time at the designated pick-up point for transport to launch. Daily pick-up times will be communicated by the organization.

**Please note: transportation to launch and return transportation after landing are the sole responsibility of each pilot, and the cost of such transportation must be covered by the pilot.**

After landing, the pilot must inform the organization via the official WhatsApp group with the following details:

1. Confirmation of a safe landing.
2. Exact location.

Once the pilot reports their location, **they must arrange their own transportation.**

Reporting via mobile phone is **mandatory**. The organization will provide the relevant phone number on the task board for WhatsApp communication.

Pilots who do not report to the organization using this system (or any other method) before the daily deadline will be considered **missing**, and a search will be initiated using rescue resources. In the event of a false alarm, the pilot will be held financially responsible for any resulting costs.

If the pilot is unable to send a WhatsApp message, they must contact the organization via radio or through another pilot's phone.
