

## NOTICE OF ASSUMPTION OF RISK - PARTICIPATION AGREEMENT - DRAGON HIKE AND FLY 2025

By participating in the Dragon Hike and Fly, organised by Crickhowell Paragliding Ltd, I acknowledge and accept that there is always an element of risk of personal injury or death in the sport of paragliding, and that the level of this risk can increase in a competition environment. I am aware that trail running/walking involve various additional risks, dangers and hazards, and the possibility of personal injury, death or loss of property.

I am also aware that weather conditions in mountainous regions may be extreme and can change rapidly.

• I acknowledge that the event organisers cannot eliminate these, or other, risks.

I further acknowledge and accept the risks, which include, amongst others, the risk of injury or illness in remote places without medical facilities; the ever-present danger posed by other pilots, including accidental mid-air collisions and the risks presented by changes in weather conditions during the event or by inaccurate weather forecasts and unexpected turbulence.

I acknowledge that in the event of illness or accident, rescue and medical treatment may not be immediately available and that mobile phones may not work. Further risks, dangers and hazards may arise through negligence of other participants or failure of the event's volunteer staff to fully safeguard or protect me from the various risks, dangers and hazards referred to above.

I acknowledge and accept that risks exist which arise both before and after this event. These include, amongst others, the risk of accident during travel by, car, truck, bus, and other means of transportation: and I acknowledge and accept that standards of driving vary across the world and that there is no guarantee that drivers hold a driving licence or adequate insurance.

- I acknowledge and accept that all of the above risks exist throughout the sport and can arise without anyone being at fault.
- I warrant that I have not, nor, will not, consume alcohol or any illegal substances prior to, or during, racing activity within this event.
- I confirm that I agree to allow photographic images of myself to be used by the organisation for promotional purposes.
- I confirm my understanding that it is my responsibility to ensure that I am covered by a policy of insurance in respect of my participation in this event that covers medical expenses incurred and search and rescue costs, including helicopter airlift, if required.

## RELEASE OF LIABILITY, WAIVER OF CLIAMS AND INDEMNITY AGREEMENT

In consideration of Crickhowell Paragliding Ltd accepting me as a participant in this event, I hereby agree as follows: TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the event, it's officers, agents, independent contractors, subcontractors, representatives, successors and assigns (all of whom are hereinafter referred to as the "RELEASEES") AND TO RELEASE THE RELEASEES from any and all liability for any loss, damage expense or injury including death that I may suffer, or that my next of kin may suffer as a result of my participation in this paragliding and hiking (Hike & Fly) event and, due to any cause whatsoever, including negligence, breach of contract, or breach of any statutory or other duty of care, on the part of the releasees, and further including the failure on the part of the releasees to safeguard or protect me from the risks, dangers and hazards of adventure activities referred to above; TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any property damage or personal injury to any third party resulting from my participation in the event.

This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, and representatives, in the event of my death or incapacity;

This Agreement and any right, duties and obligations as between the partes to this Agreement shall be governed by and interpreted solely in accordance with the laws of the UK and no other jurisdiction; and

Any litigation involving the partes to this Agreement shall be brought solely within the UK and shall be within the exclusive jurisdiction of the courts of UK.
