COMPLAINTS AND PROTESTS

As per Section 7 and 7L.

Complaints must be filed within 30 minutes after the provisional results are published. Protests may be made 30 minutes after the complaint decision announcement. A complaint fee is 40 EUR, a protest fee is 50 EUR. It must be paid upfront. Both fees are refunded if the complaint/protest is upheld. Complaints and protests must be made in a written form and delivered personally to the meet director or sent by mail (and verbally to the meet director). Complaints are resolved by the meet director. Protests are resolved by the protest committee (task committee + meet director).
