### SELECTION AND REQUIREMENTS

#### Maximum number of pilots:

100

#### Selection

- 40 places for participants of the State championship (selection via state ranking 2025 in XCCup.net)
- 20 Wildcards by the organizer
- All other participants will be selected based on their WPRS ranking as of January 2026, with pilots participating in the Moseltrophy 2026 and thus the Deutsche Mittelgebirgspokal taking precedence over the WPRS ranking.

#### Insurance

Each participant takes part in this competition at his own risk. Claims against the promoter, the host, the organizer, the competition manager as well as their helpers due to simple negligence are excluded - See Liability disclaimer for DHV Competitions.

Proof of liability insurance with coverage of at least 1.5 million euros must be presented to the organisers in German or English before the start of the competition, as well as accident insurance covering medical assistance and compensation. Helicopter rescue insurance is compulsory.

In case of a cancellation by the pilot

- **more than 60 days before competition start date: 100% refund will be granted.**
- **less than 60 days before competition start date: 100% minus adequate deduction due to administration will be refunded to the pilots.**

In case of event cancellation by the organiser:

- 100% refund minus fixed costs.
