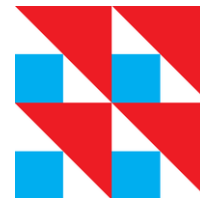

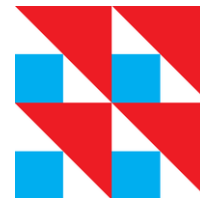

SELECTION AND REQUIREMENTS

Maximum No of Pilots: **130**

Selection Criteria:

QUALIFYING

- The event is open to all pilots of any level of wing.

SELECTION

Starting in January, the first 2 weeks of selection are open ONLY to the top 200 pilots from the WPRS or top 30 female pilots in the female WPRS..

The pilots are given 7 days to make payment for their entry – and will then revert to the second round of selection if they fail to make payment

Weeks 3 to 6 are then open for selection to the next pilots in the WPRS

If a selected pilot fails to meet the payment deadline, they shall revert to the waiting list, and must contact the organizer directly for re-selection.

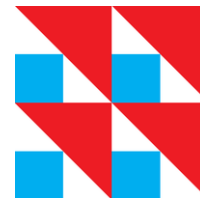
PAYMENT

- Payment will be made by Paypal. Details will be sent by email if your application to participate is accepted.

- If you receive a payment offer you should pay immediately, otherwise we will offer your place to another pilot on the waiting list.
- Do ensure you have read the cancellation policy before making any payment!

INCLUDED

The payment will get you:

- One full practice day
- Up to six quality tasks
- Daily transport to launch for all tasks, including the practice day
- Retrieves daily
- Daily lunch packs
- Trackers, for safety and scoring
- Typical tasking/scoring services
- T-shirt & other souvenirs as we are able
- Discounts for alternative activities in the event of bad weather
- Other event benefits, as they are made available

REQUIRED BY YOU

All Pilots must hold the following:

- An FAI Sporting Licence (Don't confuse this with an IPPI card)
- Medical/Travel insurance
- Third party liability insurance (usually from your National Organisation)
- A mobile phone
- Recently repacked reserve parachute
- Helmet, certified for paragliding use
- Harness with certified back protection
- 2M Radio capable of 143.900 Mhz FM

If you do not have ALL of the above you will NOT be permitted to participate.

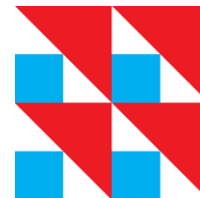

CANCELLATION AND REFUND POLICY

CANCELLATION BY YOU

Pilots who want to cancel their registration should do it as soon as possible.

- A pilot who cancels at least 45 days before the event start can ask for a refund of their deposit, less an administrative fee of 60.
- Cancellations received less than 45 days before the event start will lose the deposit and not be refunded. Nothing further will be due.

Cancellations must be informed by email and the date at which the email is received will be used to calculate your refund, if one is due.

- Refunds are not immediate. We have one admin day per month.
- Your deposit and/or payment is **NOT** transferable to another pilot. There is a strict selection process and you cannot bypass this by passing your payment to another pilot.
- Please ensure you have adequate holiday travel insurance to cover any losses if you later find you are unable to participate.

CANCELLATION BY US

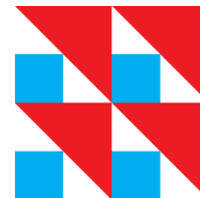
In the event the organisers deem it necessary to cancel, relocate, or reschedule the competition you will be entitled to a partial refund:

- Up to 7 days before the event start : 50% of the deposit
- Less than 7 days before the event start: A percentage of funds once any costs incurred by the local organiser have been deducted.
- After the start of the competition any refunds will be at the sole discretion of the organisers.

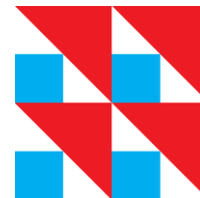

COMPLAINTS AND PROTESTS

Complaints will be dealt with as per the FAI SPorting Code, Section 7 and its sub-catogories

OTHER LOCAL RULES

- Stopped tasks subject to 5 minutes wind-back.
- Cloud flying rules as section 7, except the last day where warnings are not valid.
- The Mandatory Safety briefing is Mandatory or the pilot will be excluded from the event.
- All Two liner gliders must fly with Performance limiters fitted as defined at the initial briefing
- Three liner wings are excluded from needing to fly with Performance Limiters
- The trim tolerance, for AoA, is limited to 10mm fast for this event, as per the PWC rules.
- Flying with the Performance Limiters, as assigned to you, is mandatory
- Answering questionnaires when requested is mandatory. Any pilot that fails to answer the surveys may be ineligible to wing the prize money or take the podium.
- RFC wings may be presented at the event providing they are pre-registered with the organisers
- ESS may be scored by removing 0.3 seconds from the ESS time per metre above goal, up to a limit of 200 metres. Referred to as ESS-AB.
- Goal may be elevated. Those arriving low may receive less points if they do not reach the required altitude. Referred to as Elevated Goal.
- The tracker is the primary scoring device. A secondary device can only be presented for altitude corrections if the primary device has failed or if there is a penalty enforced against a pilot. Only one alternative device may be presented. The device must be the FAI approved instrument list.

PRIZES

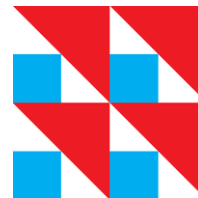
- 1st Overall - 400€ + refund entry fee
- 2nd Overall - 400€ + refund entry fee
- 3rd Overall - 400€ + refund entry fee
- 4th Overall - 300€ + refund entry fee
- 5th Overall - 200€ + refund entry fee

- 1st Female - 400€ + refund entry fee
- 2nd Female - 300€ + refund entry fee
- 3rd Female - 200€ + refund entry fee

In the event a woman wins two prizes, she will receive the more significant of the two and the lesser prize will be awarded to the next female in the class.

Entry fee prize refunds will be within 5 days. Prize money may be up to 30 days before it is processed and paid. The pilot must put a formal request for payment to the organisers, with bank details, such that CIVL can organise the payment.
